1. Name of the Society :

2. Location of the Society :

The Registered Office of the Society Shall be at H.NO.7-1-282/C/59, Plot no 59, B K Guda, Yellamma Temple, S R Nagar, Ameerpet, Hyderabad, Telangana - 500 038.

3. Aims and objects:

- [a] To under take the development of education, training and research in any field including technical and medical.
- [b] To Promote, develop and improve scientific exchange of knowledge as well as technical and medical co-operation between similar research institutions.
- [c] To organize technical courses, conferences and publications.
- [d] To develop new/ improve any of the existing technical knowledge For the betterment of Society.
- [e] To provide for all facilities including fellowships, scholarships, aid, etc., for any technical research work.
- [f] To build, maintain, and run necessary infrastructure including Research Laboratories for realization of any of the above objects.
- [g] To open, find, establish, promote, set up, run, maintain, support And/ or to help in setting up, maintenance and / or administration of any Primary (including Pre-Primary), Secondary, Higher and Professional or like courses of Engineering, Pharmacy, Management, Medical, Dental and other paramedical courses.



DOCUMENT NO.II

RULES & REGULATIONS
OF
RAVIPUDI EDUCATIONAL SOCIETY

1. Name of the Society:

The name of the society shall be **M/s. RAVIPUDI EDUCATIONAL SOCIETY**

2. Location of the Society:

The Registered Office of the Society Shall be at H.NO.7-1-282/C/59, Plot No 59,
B K Guda, Yellamma Temple, SR Nagar, Ameerpet, Hyderabad-500 038,
Telangana.

3. Membership:

The total membership of the Society shall not exceed 50 members at any time.

- a) The signatories to the Memorandum of Association shall be the first members of the Society and they need not pay admission or subscription fee as prescribed in Clause 4 (b).
- b) Any individual with an age of 18 Years or of above is entitled to become Ordinary members of the Society. Provided their membership is ratified by the Governing Body and General Body.
- c) Membership will be as ordinary member only.
- d) The membership in the Society is not transferable. However, it shall be heritable subject to nomination, communicated by the member to the office of the society in writing.
- e) Provided however such a nominated person shall not be entitled to become a member of society, if the general body of the society disapproves such nomination by $\frac{3}{4}$ majority of the total members for the misconduct on the part of such nominee for valid and justifiable reasons.
- f) Notwithstanding any thing to the contrary contained in these rules and regulations, so long as moneys remain owing by the Society to any financial institutions or banks out of any loan granted by them to the Society or any liability of the Society arising out of any guarantee furnished by the financial institutions or banks on behalf of the Society remains outstanding, such institutions or banks shall have a right to appoint from time to time any person or persons as members as their nominees shall not be liable to retirement by rotation nor the Society shall have any power to remove from office the nominees.

4. Method to become a Member:

- a) Persons as referred to in Clause 3 above desiring to enroll themselves as members shall apply for membership to the president of the Society on the prescribed form. An applicant may be enrolled as a member provided his/her application is approved by the Executive Committee by at least 2/3 majority.
- b) Every member shall have to pay the admission fee and an annual subscription as prescribed by the Executive Committee from time to time.
- c) The admission fee for ordinary membership and annual subscription shall be decided by the Executive Committee from time to time.

5. Cessation of Membership:

Membership of the Society shall terminate automatically on the death of the member or on member failing to renew the membership or on member's voluntary resignation or involuntarily on termination of his membership by the Executive Committee and such a course be deemed necessary in the interest of the Society.

6. General Body:

- a) All members enrolled as a member under clause 4(a) above shall form the General Body of the Society.
- b) The General Body shall exercise general supervision over the working of the Society.
- c) Not with standing the generality of the powers vested in the General Body of the Society all contracts, liabilities, debts or any other matter involving monetary issues shall be subject to approval of the governing body.
- d) An Annual General Body meeting of the members shall be held once in a year for the purpose of passing annual accounts and for transacting any other business as may come before the meeting at the Registered Office of the Society unless otherwise determined by the Executive Committee.
- e) Special meeting may be called by the General Secretary of the Executive Committee or by minimum 1/3rd of the members having voting rights by giving a notice in writing.
- f) A notice in writing stating the place, day and hour of any meeting shall be sent to every member entitled to vote at such meeting not less than 10 days before the day of such meeting by the Executive Committee.
- g) Quorum for the General Body Meeting will be 1/4th of the total members and the decision shall be taken by the majority vote. The Chairman shall have a casting vote in case of tie. In the absence of the quorum the meeting shall stand adjourned and shall be held at the same place after 30 minutes. No quorum shall be necessary for an adjourned meeting.

7. Executive Committee:

- a) Affairs of the Society shall be managed by the Executive Committee of the Society to be elected by the General Body of the Society. The Executive Committee shall consist of not less than 7 members.
- b) The Executive Committee including the office bearers shall hold the office for a period of five years.
- c) The Executive Committee shall meet at least once in 6 months to transact such business in connection with the management of the Society as may be considered expedient and or necessary for which requisite agenda shall be submitted to the members of the board at least 7 days in advance of the meeting. The quorum for the Executive Committee meeting shall be $\frac{1}{3}^{\text{rd}}$ of its strength.
- d) Without in any manner limit the general powers of the Executive Committee to manage the affairs of the society for attainment of its objects, the Executive Committee shall also have the following powers.
 - i. To acquire movable and immovable properties in the name of the Society and hold the same as trustees.
 - ii. To convert property movable and/ or immovable or any part of the society's fund in to cash by selling or otherwise disposing the same and thereafter re-invest the same in any security, properties, movable or immovable or otherwise.
 - iii. To grant, convey, transfer, mortgage, charge, let out, gift, settle or otherwise deal with any immovable property belonging to the Society for the purposes of the society in such a manner and on such terms as the Executive Committee may in their absolute discretion think fit.
 - iv. To invest any surplus funds not needed for immediate scientific research work by the institute only in deposits of Nationalised Banks or Government Securities or such other public investments approved specifically by the authority.
 - v. To operate or raise moneys or secure the payment of any moneys borrowed for the purposes of the Society by pledge, hypothecation, charge or mortgage of whole or any part of the movable or immovable properties comprised in the society's fund on such terms as the Executive Committee may in their absolute discretion think proper.
 - vi. To sell by public auction or private contract or exchange, gift or transfer or assign or grant, lease or sub-lease for any terms however long or otherwise dispose of or permit to be used at such rent, compensation or fee all or any part of the society's fund including movable and immovable properties comprised therein and on such terms and conditions relating to title or otherwise and in all respects as they may think proper and to rescind or vary and contract for sale, mortgage, gift, assignment, lease or other disposition and to resell the same or enter into a fresh contract for sale, exchange, transfer, assignment, gift, lease or other disposition with any person.
- e) The Executive Committee may meet from time to time as they may deem fit for which a notice of at least 7 days shall be given by the secretary. Any urgent meeting can be called on a notice of 24 hours with the approval of the president. $\frac{1}{3}^{\text{rd}}$ of the total members shall form the quorum.

g) Powers and functions of the office bearers:

i) **Chairman:** The post of the Chairman shall be honorary and elected by the Executive Committee out of their own members for a period of 5 years. He presides over all the meetings of both general body and Executive Committee. The affairs of the Society shall be managed by the Chairman of the society under the control and direction of the society and under the control and direction of the E.C. In case of equality of the votes the Chairman can exercise a casting vote.

ii) **Vice Chairman:** The post of the Vice Chairman shall also be a honorary and elected by the Executive Committee out of their own members for a period of 5 years. He/She will discharge the functions of the President in his absence.

iii) **Secretary:** The post of the General Secretary shall be honorary and elected by the Executive Committee out of their own members for a period of 5 years. He/she is the Chief Executive officer of the society and Custodian to all records relating to the society and correspondent on behalf of the society. The Secretary shall be responsible for convening meetings, maintenance of minutes, correspondence and all matters assigned to him by the Executive Committee.

iv) **Joint Secretary :** The post of the General Secretary shall be honorary and elected by the Executive Committee out of their own members for a period of 5 years. He/she have to discharge the duties the secretary in the absence of the secretary.

v) **Treasurer:** The post of the Treasurer shall be honorary, and elected by the Executive Committee out of their own members for a term of five years but is responsible for all the financial transaction relating to the society. He/she has to maintain accounts properly. He has to operate the Bank accounts jointly with Secretary or any other person as decided by the Executive Committee.

1. The society shall indemnify and keep indemnified the members of Executive Committee and save them harmless against any claim, costs, charges, expenses, losses or damages or against any proceedings against the Members of Executive Committee for any bonafide act or any bonafide omission on their part in the discharge of their obligations as such members here-under or in the exercise of any power pursuant to the provisions of these presents save and except any liability on account of willful neglect or willful default or misappropriation by some dishonest act relating the society's fund.
2. The members of the Executive Committee may reimburse themselves and pay and discharge out of the society's funds or money in their hands all expenses incurred for the purpose of society. It is expressly agree and declared that the Members of Governing Body shall be entitled to be paid their actual traveling, boarding, lodging and other expenses which may be incurred by them in the performance of their duties as such members including all expenses for the attendance of their meetings.
3. The Board of Governors shall have the power to constitute various committees for such purposes or such periods as are deemed proper by the Board.

8. Funds:

The funds of the society shall consist of admission fee, subscription, contributions, donations, grants etc.

All funds of the society shall be utilized only for the attainment of the objectives of the society and no portion thereof shall be paid, transferred directly or indirectly to any of its members. The investment of funds of the society shall be made in accordance with the proviso of sec. 11(5) of the IT Act, 1961.

9. Books & Records:

The society shall keep correct and complete books and records of the accounts and have them audited by a chartered accountant and shall also keep minutes of the proceedings of the Members and Executive Committee and shall keep at the registered office or principal office a record giving the name and address of the members entitled to vote.

10. Amendments.:

No amendments or alteration shall be made in purpose of the association unless it is voted by 2/3rd of the members present at a special meeting conveyed for the purpose, and with the prior approval of the Commissioner of Income Tax Exemptions..

The Memorandum of Association of the society and its rules and regulations may from time to time can be altered or abridged revoked or re-enacted by majority of the votes at a meeting conveyed in accordance with the particular provision of the A.P.Societies Registration Act, 2001.

11. Financial Year:

The Financial accounts of the first year shall close as on 31st March, and thereafter the accounting year of the society shall be from 1st April to 31st March each year.

12. Bank Account:

All funds of the society shall be kept in its account with any scheduled banks and such accounts shall be operated by such office bearers/ employees of the society as may be decided from time to time by resolution of the Executive Committee.

13. Winding Up:

In the event of dissolution of the society the property and funds of the society that remain after full satisfaction of the liabilities of the society shall be transferred or paid to some other institution with similar aims and objects and which is registered under section 12(a) of the Income- Tax act, 1961 by the Commissioner of Income-Tax Exemptions.

The Society may be dissolved at a General Body Meeting convened for the purpose by majority of at least 2/3rd of the total members and there upon all steps shall be taken for the disposal and settlement of the entire funds and property of the society, its claims and liabilities as may be decided by the Governing Body.
